Motion by Mr. Lawson, second by Mr. West that Council Bill No. 2019-104 be approved on an emergency basis. Voting in favor were Council Members: Brown, Colbert-Kean, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett, and West, 9. Nays: 0. The Council Bill Was declared adopted and entitled **Ordinance 2019- 012**.

Mr. Stinnett introduced Council Bill No. 2019-105 – an ordinance authorizing the acceptance of an agreement by and between the City of Joplin and Capital Paving & Construction, LLC., for the Reconstruction of Taxiway D at the Joplin Regional Airport; and containing an emergency clause. Motion by Mr. Stinnett, second by Mr. Stanley that Council Bill No. 2019-105 be approved on an emergency basis. Voting in favor were Council Members: Brown, Colbert-Kean, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett, and West, 9. Nays: 0. The Council Bill was declared adopted and entitled **Ordinance 2019-013**.

Mr. Stanley introduced Council Bill No. 2019-106 - an ordinance authorizing the acceptance of an agreement by and between the City of Joplin and Crawford, Murphy & Tilly, Inc., for Construction Observation Services for the Reconstruction of Taxiway D at the Joplin Regional Airport; and containing an emergency clause. Motion by Mr. Stanley, second by Mr. Stinnett that Council Bill No. 2019-106 be approved on an emergency basis. Voting in favor were Council Members: Brown, Colbert-Kean, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett, and West, 9. Nays: 0. The Council Bill was declared adopted and entitled **Ordinance 2019-014**.

Mrs. Reid Adams introduced Council Bill No. 2019-107- an ordinance authorizing the City of Joplin to enter into an Equipment Transfer Agreement between the Joplin Regional Airport and the Kirksville Regional Airport for the Rousenbauer Airwolf ARFF truck; authorizing the City Manager to execute the same by and on behalf of the City of Joplin; and containing an emergency clause. Motion by Mrs. Reid Adams, second by Mr. Brown that Council Bill No. 2019-107 be approved on an emergency basis. Voting in favor were Council Members: Brown, Colbert-Kean, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett, and West, 9. Nays: 0. The Council Bill was declared adopted and entitled **Ordinance 2019-015**.

Mr. West introduced Council Bill No. 2019-604- an ordinance approving the reclassification of a position for the Police Department; and amending the Annual Budget of the City of Joplin for the Fiscal Year 2018-2019 as adopted by Ordinance 208-145 on October 15, 2018. Motion by Mr. West, second by Mr. Lawson that Council Bill No. 2019-604 be approved on First Reading and advanced to Second and third Reading. Voting in favor were Council Members: Brown, Colbert-Kean, Lawson, Reid Adams, Shaw, Stanley, Stinnett, and West, 8. Abstention: Monteleone, 1. The Council Bill was read as **Council Bill No. 2019-604.**

#### **News from Public Information Officer Lynn Onstot:**

The City of Joplin has announced that the annual leaf pick-up program has ended with all residential areas being canvassed. However, if residents still have leaves, the City crews will provide “special request pick-ups.” Residents wanting to place their address on the pick-up list should call the Parks Department at 625-4750 between 9 a.m. and 4 p.m. by January 28.

Tickets are now on sale for the annual Daddy Daughter Date Night hosted by the Joplin Parks and Recreation Department. This year’s date nights are Friday, February 15<sup>th</sup> and Saturday, February 16<sup>th</sup>. The event is held from 6:30-9 pm at Memorial Hall and includes music, dancing, games buffet dinner, prizes and a complimentary picture.

The program is designed for dads, uncles, grandfathers, or other father figures, whose daughters are 3-12 years old. Due to limited seating, pre-registration is required. **Comments from City Council:**

Mr. Brown stated he has a friend that is a runner; he ran to his house from Schifferdecker to Mr. Browns house which is on St. Louis and Zora, and he mentioned he was able to run on sidewalk the entire way; Mr. Brown gave a thank you to those that made that happen.

Mr. Monteleone mentioned he received an email from a resident about a dangerous intersection in his neighborhood; McKinley to between 9<sup>th</sup> and 11<sup>th</sup>; he forwarded that information to the City Manager to look into that to see if it is indeed dangerous. Mr. Monteleone also mentioned a moment of gratitude; a lot of people in the city he is grateful for keeping the roads safe over the past weekend with the bad weather: Dean Smith, Scott Buffer, Joey Burton, Jimmy Cawyer, Larry Beaver, Travis Shafer, Freddy Butler, Wes Showalter, Ethan Ketterman, Cody Marti and Monty Johnson. They all did tremendous work being out on the trucks and keeping everyone safe.

City Manager Sam Anselm stated regarding the resident's email on South McKinley; the crime analyst was able to look back over the last three years in that neighborhood and was unable to find any reports of accidents. The City Manager will let the resident know that if there is an accident to make sure and call the police to report it. Also, the traffic engineer will be adding this location to the list. He also mentioned the City has developed a Traffic Calming Policy; they have a draft copy at this time and expect to make some finalizations at the next meeting in March.

Mayor Shaw mentioned he along with several other Council members attended the Martin Luther King Jr. breakfast at Missouri Southern on Monday. He thanked Missouri Southern for putting that event together.
