

**JOPLIN CITY COUNCIL
MARCH 2, 2020
MEETING MINUTES**

CALL TO ORDER

The March 2, 2020 regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Gary Shaw.

INVOCATION was read by City Clerk Barbara Gollhofer.

PLEDGE OF ALLEGIANCE to the United States of America was led by Mrs. Colbert-Kean.

As part of the Annual Severe Weather Awareness Week, the City of Joplin will participate in the statewide tornado drill at 10 a.m. on Tuesday March 3. Joplin's outdoor warning sirens will sound for a full three minutes, just as they would in an emergency. We encourage all residents to use this drill as an opportunity to plan and prepare for a real situation. This is a good time to discuss sheltering plans with your family and co-workers and to check that you have a working battery-operated radio and flashlights, along with other necessary supplies in your designated "safe place."

The City begins its Tree Limb Drop Off Service on the 3rd Saturday of each month. It will be open from 8:30 a.m. to 3 p.m. on Saturday, March 21. This drop off site will be open the third Saturday of the month from March through October, unless there is a weather event that warrants another date being set. The drop-off site is located at 1702 North Schifferdecker Avenue, six tenths of a mile north of Belle Center Road on the west side of Schifferdecker. This free drop-off service is for Joplin residents only and has no load limits.

The First Thursday ArtWalk is set for Thursday, March 5, and Downtown Joplin will kick off the 3rd Thursday events on Thursday, March 21.

Corona Virus Update


Health Director Dan Pekarek discussed the procedures if the corona virus spreads to Joplin. He said the Jasper and Newton Counties health officials have been monitoring reports of the illness and will follow the procedures established for a pandemic flu outbreak if the virus spreads here.

The public would be notified of the status of any outbreak and what people should do to minimize the risk of exposure.

Vote to go into closed session, which shall pertain to legal action, causes of action, or litigation including a public governmental body and any confidential or privileged communications between a governmental body or its representatives and its attorneys; and the hiring, firing, disciplining, or promotion of an employee or particular employees of a governmental body involving personal information; as set forth in Section 610.021(1) (3) RSMo, as amended, 2019. This meeting, record, and vote to be closed to the extent provided by law. The City Council shall adjourn at the end of the session. Motion by Mr. Stanley, second by Mr. Cortez to go into closed session. Voting in favor were Council Members: Brown, Colbert-Kean, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley and Stinnett, 9. Nays: 0.
