JOPLIN CITY COUNCIL MEETING MINUTES August 17, 2020

CALL TO ORDER

The August 17, 2020 regular meeting of the Joplin City Council was called to order at 6:00 p.m.by Mayor Ryan Stanley.

INVOCATION was read by City Clerk Barbara Gollhofer.

PLEDGE OF ALLEGIANCE to the United States of America was led by Mr. Lawson.

Health Dept. Update/Discussion of Covid-19 Recovery Plan

Mayor Stanley stated that after the health update, the city council will hear the requests to address Council, then City Council will discuss the mask ordinance and reopening plan.

Acting Health Director Dan Pekarek gave the following COVID-19 health update:

• As of August 16, there are 499 confirmed COVID-19 cases, 67 active, 411 inactive, 21 deaths, 116 quarantined, total of 38 COVID patients hospitalized (3 Joplin residents).

Requests to Address Council:

Ronald Burch, Carthage MO, requested permission to host a cruise for the JOMO Pride Cruise on August 30 and to waive the permit fee. Motion by Mr. Copple, second by Dr. Reid Adams to approve the cruise. Voting in favor were Council Members: Copple, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett and Williams, 9. Nays: 0.

There was discussion after the vote regarding previous direction to city staff to come up with a fee schedule for cruising. Staff has not had time to work on this issue but will work on it in the near future for Council's review and approval. Mr. Stinnett suggested the special event fee be applied to the cruise request. Recess

Mayor Stanley called for a 10-minute recess at 9:50 p.m.

The meeting reconvened at 10:00 p.m.

Recovery/Reopening Plan Discussion

1) The school district is seeking the City's approval for a proposal that would allow a stadium capacity of 50%.

After discussion, Mr. Lawson made the motion to exempt the schools from the Reopening Plan and let the schools (school board) work with the Health Department to create their own rules. Mr. Copple seconded the motion. Voting in favor were Council Members: Copple, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett and Williams, 9. Nays: 0.

2) Should the mask ordinance be allowed to expire or be extended?

After discussion, Mr. Cortez made a motion to extend the mask ordinance to September 21, 2020, move to Step 3 of the Recovery Plan with no occupancy restrictions and mass gatherings restrictions. Dr. Reid Adams seconded the motion. Voting in favor were Council Members: Cortez, Monteleone, Reid Adams and Williams, 4. Nays: Copple, Lawson, Shaw, Stanley, and Stinnett, 5. The motion failed.

Motion by Mr. Shaw, second Mr. Lawson to strongly urge the adoption of mask use in public places and drop the mandate. Voting in favor were Council Members: Copple, Lawson, Shaw, Stanley and Stinnett, 5. Nays: Cortez, Monteleone, Reid Adams, and Williams, 4. The motion passed.

3) Should the City remain at the current step in the Reopening Plan?

Motion by Mr. Lawson, second by Mr. Shaw to move from Step 2 to Step 4 of the Reopening Plan. Voting in favor were Council Members: Copple, Cortez, Lawson, Reid Adams, Shaw, Stanley Stinnett, and Williams, 8. Nays: Monteleone, 1. The motion passed.

News from Public Information Officer, Lynn Onstot

Starting today, West 4th Street is closed between Porter Avenue and Empire Avenue for a stormwater project in the area. This closure will be in place four weeks, weather permitting. Crews will replace a culvert just south of 4th Street and running under the street. During the Labor Day weekend, 4th Street will reopen at 5 p.m. Friday, September 4 through 5 a.m. Tuesday, September 8, at which time work will continue on the project. Drivers should follow detours marked.

Starting next Monday, August $24 - \text{East } 7^{\text{th}}$ Street between Illinois and just west of Michigan will be closed for 14 days. Crews will connect the stormwater improvements that have been recently completed just north and south of 7^{th} Street.

Citizens are invited to a public meeting on Thursday, August 20 to discuss the future of Ewert Pool. This come and go meeting runs from 4:30 to 6:30 p.m. and will be held at Ewert Pool. Meeting participants can view the current facility, review possible options for the future of this area and take a survey noting their preferences. We encourage everyone interested in Joplin's Parks to please attend.

Later this week, the City will also launch the Memorial Hall Study in which we're reviewing the current facility and asking citizens on their thoughts of how they'd like the City to proceed with Memorial Hall. A public survey will go live this Friday, so watch for that announcement through Facebook, the City's website and our local news stations. In addition, we'll host a Public Meeting about Memorial Hall's future next Thursday, August 27. It will be held from 4:30 to 6:30 p.m. in the Cafeteria of the Memorial Education Center at 825 Pearl Street. (Some might remember this building as Memorial High School.) Again, this is a chance for citizens to share their thoughts at public meetings and through the survey that comes out later this week. We'll have more details on both projects as we begin the public input process, We ask citizens to please watch for announcements on ways they can participate.
